



Richard Lennan, who is Professor of Systematic Theology Richard taught at Weston Jesuit School of Theology Faculty. He currently directs the STM's Licentiate in Sacred Theology (STL) program, serves on the editorial board of Theological Studies and chairs the steering committee of the Karl Rahner Society. Richard has authored two books and edited five others.

Subsequently she studied canon law at Saint Paul University, Ottawa and at the University of Ottawa (degrees: Master and Licentiate, 1988; PhD and Doctor of Canon Law (JCD) 1990). In 1997 Myriam completed the habilitation at the Westfälische-Wilhelms-Universität Münster. (Germany).

After visiting professorships at The Catholic University of America (Washington DC) from 2001-2003 and Saint Paul University in Ottawa from 2004-2006, as well as being an assistant professor at the University of Tilburg (1999-2005), Myriam was appointed as full professor for Canon Law at the Since 1988 Prof. Wijlens has engaged in the topic of child University of Erfurt in 2005. The Pontifical Council for the Promotion of Christian Unity (Vatican) appointed Myriam as its delegate to the Standing Committee of the Faith and Order Commission at the World Council of Churches (Geneva) in 2008. In 2014 the delegation was renewed till 2022. In 2012 the same Pontifical Council mandated Myriam Wijlens to serve on the Consultation between the Roman Catholic Church and the Community of Protestant Churches in Institutions: Law - Causes - Prevention". Europe. 2019 she was appointed as an expert to the Anglican Roman Catholic International Commission (ARCIC).

honorary professor for Ecumenism and Canon Law from 2012-2021, where she attends in particular to Receptive Ecumenism. Since 2004 Myriam Wijlens is co-moderator of the international research group "Peter and Paul Seminar" which focuses on necessary reforms of structures in the church. Hence, her own research focuses on ecclesiological and ecumenical themes with a particular attention for canonical issues. Other areas of research concern sexual abuse of minors and the law on consecrated life in religious institutes.
